WATER RATES

- **WHEREAS**, the District charges rates for water service as authorized by California Public Utility Code Section 16467; and
- WHEREAS, the District's existing streams of revenue are insufficient to fund the anticipated expenses over the next five years; and
- WHEREAS, a water cost of service study, prepared by Weber, Ghio & Associates, is on file at the District office, available for public inspection during normal business hours and incorporated herein by reference (the "COS Study"); and
- **WHEREAS**, at its June 10, 2018 meeting, the Board of Directors considered and approved the COS Study; and
- WHEREAS, at that same meeting, the Board of Directors instructed staff to set a public hearing pursuant to Article XIII D, Section 6 (a portion of Proposition 218) with respect to the water rate increase described in the COS Study;
- WHEREAS, on June 29, 2018, notice of the public hearing, including all information required by applicable law, was mailed to the record property owners of parcels affected by the proposed increase; and
- **WHEREAS**, a Public Outreach was held on July 10, 2018 to provide an opportunity for property owners and residents to learn more about the proposed water rate increase; and
- WHEREAS, on August 14, 2018, at the time and date set forth in the notice mailed to property owners, the Board of Directors held a Public Hearing at which all interested persons had an opportunity to present oral and written testimony regarding the proposed water rate increase; and
- WHEREAS, the District received written protests against the proposed water rate increase with respect to less than a majority of the affected parcels; and
- **WHEREAS**, the Board of Directors finds that the proposed rate increase satisfies each of the requirements set forth in Article XIII D, Section 6(b) of the California Constitution; and
- **WHEREAS**, the Board of Directors, having carefully considered all testimony received, now desires to approve the proposed water rate increase
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors of the Calaveras Public Utility District does hereby establish the water rate schedules attached hereto as Exhibits "A, B, C, D, and E" and incorporated herein by reference. The schedule set forth as Exhibit A shall be effective on the billing cycle commencing on August 26, 2018, and each subsequent schedule shall take effect, as indicated on the schedule, on each subsequent July 1, beginning July 1, 2019.
